INTRODUCTION

TREASURER'S NOTE

In 2014, ANU Students' Association (ANUSA) will receive over \$1.5 million in funding sourced from the Student Services and Amenities Fee (SSAF) charged to our members by the Australian National University. In accordance with s 8.2 of our funding agreement with the University, ANUSA is pleased to present "a comprehensive and detailed acquittal of expenditures incurred" over the last year.

This document covers two contractual report periods: from 1 June 2013 to 30 November 2013, and from 1 December 2013 to 31 May 2014.

In the past, all expenditures have been manually allocated to one of 19 SSAF categories outlined in the *Higher Education Support Act* 2003 (the Act). However with an increased focus on integrated and multifaceted events, we feel this reporting procedure does not provide our members with a true and fair view of our finances.

In line with ANUSA's 2014 SSAF Funding Proposal, this report takes a slightly different form. Listed below are qualitiative descriptions of activities under each of the criteria under which funds were allocated. In addition, detailed income statements covering six-monthly periods have been included.

The last six months have been an exciting time for ANUSA, with increased SSAF income providing for a raft of new initiatives as well as the expansion and enhancement of existing programs and services. This report underlines our strong commitment to financial transparency and accountability, and we warmly welcome questions from our members on any aspect of the information contained below.

ACTIVITIES

BY SSAF CATEGORY

(a) Providing food or drink to students on a campus of the higher education provider

ANUSA and its affiliate organisations are a well known source of free food on campus. Each morning from 8-10am, we serve a free breakfast in Brian Kenyon Student Space, followed by subsidised Nespresso coffee and snack foods all day. Each Thursday ANUSA organises 'Universal Lunch Hour', an initiative which provides lunch to over 300 students every week, while also providing an avenue for clubs, societies and departments to build interest and recruit new members. This has also been used to help support some excellent campaigns like the 'Safety on Campus' campaign and 'Spoon Week' run by the ANUSA Disabilities Department. Fresh, healthy food is also a major drawcard of O-Week and Bush Week, through which we offer full catering for at least two meals per day to our members.

(b) Supporting a sporting or other recreational activity by students

ANUSA supports sport and recreational activities through a variety of means. We offer weekly gold coin yoga which has been hugely successful, with donations going to charity. We started the year with first year faculty camps which had great attendance rates amongst new students, introducing them to study at ANU through a comprehensive outdoors-focused program. Throughout O-Week and Bush week, we put on a wide variety of recreational activities from Big Swing Golf to inflatable obstacle courses.

(c) Supporting the administration of a club most of whose members are students

The Grants and Affiliations Committee (GAC) provides funding to over 100 clubs and societies on campus. Student members have been able to attend subsidised conferences, balls, dances, movie screenings, meet and greets as well as travel interstate and even overseas thanks to the work of GAC. ANUSA also offers significant support to clubs in other ways, for example through the purchase of AV and other event equipment for use at events. To celebrate the excellent work undertaken by the volunteer committees of our clubs, ANUSA hosts an annual awards dinner to recognise their accomplishments.

In addition, a large part of ANUSA's advocacy and representation of students is organised through the organisation's department structure. A significant amount of funds are dedicated to furthering the interests of particular vulnerable groups within our community, through campaigns, discussion forums and other events. ANUSA has six departments: Women, Queer*, Indigenous, International, Disabilities and Environment.

ANUSA's own administration costs include wages for nine permanent staff, utilities, IT support, vehicle maintenance, insurance, office equipment and general supplies.

(d) Caring for children of students

No funds were allocated under this criterion.

(e) Providing legal services to students

ANUSA and the Postgraduate & Research Students' Association (PARSA) jointly run a free legal service. This is run in-house by our lawyer Michael Curtotti with assistance from student interns. Michael offers advice in a broad range of areas, including migration, tenancy and employment.

(f) Promoting the health or welfare of students

ANUSA's official committees are another important channel for promoting student wellbeing. Meeting weekly, the Mental Health and Safety on Campus Committees play a vital role in guiding ANUSA policy, liaising with the universities and organising awareness initiatives. For example, the highly-regarded 2013 Student Survival Guide was reprinted in early 2014 for the benefit of new students.

(g) Helping students secure accommodation

Through our Student Assistance Unit (described above) we offer help and advice to those seeking accommodation in Canberra. Two 'Roomies' events have been run in 2014, with representatives from real estate agencies and the ACT Tenants Union on hand to answer specific questions. Our Student Assistance Officers also provide a referral service for accommodation bursaries and assist with applications for Centrelink (including Rent Assistance). ANUSA is also a supporter of Canberra Student Housing Cooperative, approving several GAC grants to promote this alternative low-cost housing option.

(h) Helping students obtain employment or advice on careers

One of our most successful programs, Skill Up, helps students build their skill base in the effort of seeking employment. Around 30 students completed a Responsible Service of Alcohol Certificate, barista course presented by local coffee roasters, and job application and interview skills training provided by the ANU Careers Centre.

(i) Helping students with their financial affairs

In 2013, ANUSA launched a rebranded Student Assistance Unit consisting of two Student Assistance Officers. Bronwyn and Carolyn oversee the delivery of many services to students in need, from the distribution of emergency grants and grocery vouchers to a generous food aid program offered in collaboration with ANU Union.

The Unit is certified by the Australian Taxation Office to provide a tax help program which is extremely popular between July and October each year.

(j) Helping students obtain insurance against personal accidents

No funds were allocated under this criterion.

(k) Supporting debating by students

ACTIVITIES

GAC has provided funding to ANU Debating Society and ANU Chinese Debating Society to support activities such as training and attendance at interstate debating competitions. ANUSA representatives have participated in other debates and panels hosted on campus, including Woroni's recent deregulation debate and ANU's 'Blow Up the Lecture' series.

(I) Providing libraries and reading rooms (other than those provided for academic purposes) for students

Brian Kenyon Student Space has been an incredible initiative maintained over the last 3 years, and continues to grow in its offering as well as the number of people who utilise the space. It is often full of a mix of student groups meeting, people studying and those who are just there for the free tea and coffee. Brian's is open 9am-5pm during semester and is regularly booked by clubs and societies after hours.

(m) Supporting an artistic activity by students

During both O-Week and Bush week, ANUSA hosted many different artistic competitions and events including our Instagram photo competitions, Crafternoons and a special appearance by Commit No Nuisance for our Bush Week Art Battle. We also proudly support the arts through our production grants administered by GAC.

(n) Supporting the production and dissemination to students of media whose content is provided by students

ANUSA, in conjunction with many of the ANUSA departments, have published several student guides on issues such as finding a place to live or studying at ANU for the first time. The International Students Guide has been one of our most popular thanks to the work of the ANUSA International Students Department (ISD).

(o) Helping students develop skills for study, by means other than undertaking courses of study in which they are enrolled

ANUSA's College Representatives play a central role in facilitiating the development of academic skills among undergraduate students. Networking events are regularly held to improve relationships between academic staff, student representatives and students. Faculty camps (see (b)) run at the beginning of the year were an important opportunity for older-year 'mentors' to share advice on study techniques.

ANUSA funded college-based clubs and societies offer their own development opportunities, for example through pre-exam tutorial programs run by the Actuarial Finance and Economics Society (AFEC).

(p) Advising on matters arising under the higher education provider's rules (however described)

The Vice-President acts as an advocate for students when discussing appeals or engaging in discussions with university staff. Through their position, they help play a vital role being someone to whom students can turn when they feel they are being unfairly treated or would like support when dealing with the

university.

(q) Advocating students' interests in matters arising under the higher education provider's rules (however described)

One of ANUSA's primary functions is to advocate students' interests at both a university level and on the higher education front more broadly. ANUSA representatives sit on all main ANU Committees and ANU Council, which comprise the primary avenue for discussing policy changes which impact students.

Beyond campus, ANUSA has worked closely with the National Union of Students on a number of campaigns fighting cuts to university funding and more recently, fighting changes presented in the 2014 Federal Budget.

(r) Giving students information to help them in their orientation

O-Week and Bush Week are the two biggest weeks on the ANUSA calendar. Through a range of social events, information sessions and recreational activities, ANUSA aims to provide a fun introduction to university while also providing an avenue to disseminate important information to new students.

(s) Helping meet the specific needs of overseas students relating to their welfare, accommodation and employment
